Historical Look at the Clerk's Office - In Ohio, the Clerk of the Common Pleas Court, which was established by State Constitution in 1802. serves the citizens, the legal community, and the Common Pleas Court. The office was created by the state's founders to be responsive to the public, mindful of the taxpayers, and independent of the court itself.





In 1851, under the State Constitution, the position became an elected position for a three year term and was extended to a four year term in 1936. William Henry Harrison, ninth President of the United States was the Hamilton County Clerk of Courts when he was elected President in 1840. The first Fairfield County Clerk of Common Pleas Court was Hugh Boyle who was appointed in 1803. The Clerk serves as the official record keeper of the court and acts as a safeguard and processor of all monies collected.

**The Present** - Today, Branden C. Meyer and his staff serves one of the fastest growing counties in the state. The office is committed to quality customer service, technological improvements for more efficient service and being fiscally responsible. The office has three locations to serve the public throughout the FAIRFIE county; the legal offices are located in the Hall of Justice in downtown Lancaster and two title offices, one in Lancaster and one in Pickerington.



Functions of the Clerk's Office - The function of the Clerk of the Common Pleas Court is to satisfy more than 250 state statutes and court rules. Among the responsibilities of the office are to: Provide public access to the records of the Common Pleas Court and the 5<sup>th</sup> District Court of Appeals; be the first stop in initiating any court action in civil, criminal or domestic relations court matters; collect and disburse court-ordered fees, fines, victim restitution in an expedient manner; receive, distribute and preserve official court documents; and be responsible for issuing and maintaining all motor vehicle and watercraft titles in Fairfield County. The Clerk of Courts office is made up of the following three departments: Administrative and Fiscal, Legal and Title.

**Mission** - The Fairfield County Clerk of Courts Office is honored with the responsibility of serving the public by maintaining the records for the Common Pleas Court, the 5th District Court of Appeals and issuing/preserving all motor vehicle and watercraft titles in Fairfield County. Through our continuous quality improvement efforts, our team is dedicated to providing efficient, courteous and professional customer service.

**<u>Vision</u>** - The vision of the Clerk is to anticipate, meet and exceed the expectations of our customers. We vow to remain compliant with the law, promise to hold our fiduciary responsibility to the highest possible standard and pledge to honor the trust bestowed upon this office with the utmost integrity, pride and respect.


Administrative and Fiscal Department - The Clerk of Courts' Administrative and Fiscal Department provides integral support to both the Legal and Title Departments by overseeing all budgetary matters and performing the statutory fiduciary duties of the office by allocating funds, disbursing payments, and issuing bond, restitution, garnishment and refund checks. The office performs all financial functions and administrative related duties, including the processing of payroll.




**Legal Department** - The Clerk of Courts' Legal Department handles documents or filings for five separate areas: the Civil Division, the Criminal Division, the Domestic Relations Division, the Court of Appeals Division and the Records Division. The Court of Common Pleas serves as a trial court for all civil, criminal, and domestic relations cases that occur within Fairfield County.




<u>Civil Division</u> - The Civil Division dockets all pleadings in foreclosures, money judgments, garnishments and other miscellaneous civil actions. The Civil Division also issues and files summonses, subpoenas, writs, Certificates of Judgment and all other related service in civil cases. The Civil Division also records all Notary Public Commissions.







<u>Criminal Division</u> - The Criminal Division files and dockets all pleadings in felony criminal cases bound over to the grand jury and all grand jury indictments. The Criminal Division also issues summonses, subpoenas, warrants, capiases and all other related service in criminal cases.



<u>Domestic Relations Division</u> - The Domestic Relations Division files and dockets all pleadings in divorce, dissolution, parenting and other miscellaneous domestic actions. The Domestic Relations Division also issues and files summonses, subpoenas, capiases, and all other related service in domestic cases.



<u>Court of Appeals Division</u> - The Court of Appeals Division receives all filings and manages all paperwork relating to cases which have been appealed to the 5<sup>th</sup> District Court of Appeals. This includes any appeals from the Common Pleas Court, Juvenile/Probate Court, and the Municipal Court in Fairfield County. As indicated in the chart to the right, there were 67 Court of Appeals cases in 2015 and 48 Court of Appeals cases in 2016.



**Records Division** - The Records Division of the Clerk's office is responsible for protecting, preserving, and disseminating official records in accordance with the records retention schedule according to state archival standards and state and federal law. The Records Division also provides public access to records for the Common Pleas Court, manages public records requests and maintains over 22 million pages of documents for both the Legal and Title Departments.


**<u>Title Department</u>** - The Title Department is responsible for issuing and maintaining all motor vehicle and watercraft titles in Fairfield County. This includes handling trailers, campers, motor homes, boats, and boat motors, all-terrain vehicles (ATV), off-highway motorcycles, wave runners, and jet skis. The Title Department also issues duplicate titles when the original has been lost or stolen, titles for new Ohio residents, and mobile home titles as well.




The Title Department processed 221,999 auto titles in 2016 compared to 204,095 in 2015 and processed 1,587 watercraft titles in 2016 compared to 1,550 in 2015. There were 223,586 titles processed in 2016, compared to 205,645 in 2015, an increase of 27,941 titles.

The Fairfield County Clerk of Courts has been designated as an authorized passport acceptance facility by the U.S. Department of State. A total of 1,721 passports were processed within the title offices in 2016, compared to 1,513 passports in 2015.







The Clerk of Courts office takes seriously its responsibility to be faithful and committed custodians of public funds. The legal operation is funded by a General Fund appropriation and the title operation is funded by the Certificate of Title Administration (CTA) Fund. The CTA Fund (See O.R.C. 4505) is generated from title fees and not included in the General Fund budget. Due to a surplus in 2016 and in order to provide the County with a solid base for achieving future goals including the purchase and renovation of the County Records Center, Clerk Branden Meyer elected to transfer \$1,000,000 from the Clerk of Courts' CTA Fund to the Fairfield County General Fund.

# **2016 ACCOMPLISHMENTS**

- Continued to implement staff training for more efficient court services, heightened productivity and procedural accountability (i.e. mandatory ethics training, Certified Public Records Training, CREST, FMLA, etc.).
- Implemented the use of Employee Self Service (ESS) and shared office calendars to handle staff leave requests.
- **→** Continued to update and create new public information guides and forms.
- → Initiated MAPSYS project within the Clerk's office to image non-financial and non-court documents for organization and safe record keeping in preparing for the future move to the County Records Center.
- Continued to participate in various workgroups initiated by the Fairfield County Commissioners and the Clerk of Courts Office (i.e. Records Center Initiative and the Baldwin Road workgroup).
- Title employees worked with the Ohio BMV and participated with the development and testing of the new statewide Auto Title Processing System, ATPS Blue.
- Increased public access to the courts through improvements to signage within the Hall of Justice building.
- Continued online and over-the-phone payment for payment of court costs and probation fees utilizing LexisNexis VitalCheck, Inc.
- Continued partnership with the Ohio Attorney General's office to handle delinquent debt collection.
- → Set up staff access through Henschen to the Fairfield County Probate Court records at the title office so employees can print off required Probate Court documents that are needed by the public to obtain their auto and watercraft titles.
- Multiple staff members participated in Community Care Day and the Clerk of Courts office organized the annual silent auction to benefit United Way of Fairfield County.
- Due to a surplus in 2016 and in order to provide the County with a solid base for achieving future goals \$1,000,000 has been transferred from the Clerk of Courts' Certificate of Title Fund to the General Fund. Over the past three years \$2.6 million has been transferred.
